



Medical Insurance

Medical Insurance (PPO) + (CCP)

We offer two types of Medical Insurance so you can choose the plan that best fits your needs. Preferred Provider Organizer (PPO) controls out-of-pocket costs in exchange for a higher premium. Consumer Choice Plan (CCP) allows greater control over what you want to pay with lower premiums but higher out-of-pocket costs. CCP also allows the option for a Health Savings Account, with company provided contributions.

Dental

We want to help our associates feel confident, and sometimes it can all start with a great smile! Our Dental Plan allows the option to use a dentist either in-network or out-of-network. Both cover biannual teeth cleanings at 100%.

Vision

Eyesight is important and ever changing. Our Vision Plan allows the ability to use an optometrist either in-network or out-of-network, but greater coverage with in-network providers. Both cover new lenses and contacts yearly with new frames every year.

Health Savings Accounts (HSA)

An HSA is a personal savings account used for qualified health care expenses with an impressive tax advantage. It is available if enrolled in a CCP Medical plan. You can grow your account through your own contributions along with the company contributions.

Infertility Treatment

We understand that everyone's journey to becoming parents is different. Our infertility plan is to help support and reduce any unnecessary stress during this stage in your life.

Adoption & Surrogacy

We have expanded family-friendly benefits beyond just fertility. JCG has added adoption and surrogacy support to the mix of our family planning benefits by providing up to \$25,000 in aid. We want to ensure we are being as inclusive as possible when we are thinking of new benefits and ensuring we are including our LGBTQ and single prospective JCG parents.

Medical Travel

We are now offering Medical Travel for ALL our associates. This will supply access to travel funds pertaining to any type of medical travel, including reproductive services, if not accessible within 100 miles, and allows up to \$4,000 for travel expenses. It's completely confidential, and there is no need for associates to outlay the money as they can access the funds at once.

Resources to Help You Be Healthy

Below are just some examples of services and resources to support your good health.

Annual Preventive Screenings

Both health plans pay 100% (with no copay or deductible) for eligible in-network preventive care, such as annual physicals, immunizations and wellness screenings.

Tobacco Cessation Program

Quitting isn't easy. That is why we offer a free program that provides the tools needed to really quit tobacco. The Quit For Life program is nine times more effective than trying on your own. Plus, anyone who does not use tobacco will receive a monthly discount on their medical premium.

One Medical

Visits to the doctor should not be complicated by long wait times with rushed appointments, missing paperwork or other healthcare inconveniences. We offer **One Medical**: a membership with personalized care, sameday and next-day appointments that start on time, onsite lab services, and 24/7 access to a provider.

Telemedicine Program

Sometimes we have medical questions during late hours of the night or we are not able to visit a doctor's office with our busy lives.

J.Crew Group offers a Telemedicine program that provides 24/7 medical consultations through any smart device with certified doctors.

Life Resources (EAP)

Having a balanced professional and personal life is important, so we give you and your family access to an employee assistance program. This program provides 24/7 free confidential help with a variety of personal and work concerns such as: stress, substance abuse, relationship, family and financial issues. The services include phone conversations and face-to-face sessions with counselors, and referrals to resources, services and support in your community.

Personal Nurse Advocate

We understand that certain medical conditions affect our daily lives, and want

to ensure our associates are always getting the help they need. This program offers a registered nurse who will work with you to develop a personal action plan to better manage your condition and improve your quality of life.


Additionally, this program will provide you with a personal advocate to help you navigate the healthcare system.


performance objectives for your role. The second session offers tools and guidance for building a robust development plan to realize your desired personal impact and career aspirations.

401(K)




Commuter Benefits

Paid Time Off (PTO)


Time away from the office is very important for both our physical and mental health. For this reason, we offer a Paid Time Off Policy that allows you to use your time how you see fit. PTO can be used throughout the fiscal year (Feb–Jan) for vacation, sick leave and personal days.

Leave Policies

We understand that situations arise requiring you to take an extended leave, but don't worry, we have your back. Whether it's completing your civic duty, time away for bereavement or other specific needs.

Parental Leave

Adding a child to your family is a wonderful time with an important adjustment period. We offer a generous parental leave to help this transition go smooth as possible whether you are a mom or dad, biological or adoptive!



Family & Emergencies

When an emergency strikes, we want to help you and your family focus on what really matters, being together.

Life Insurance

We offer a variety of Life Insurance plans for whichever best covers you and your family: Basic Life and Accidental Death Dismemberment (AD&D), Supplemental Life, and Dependent Life for your family. As your life events change, it is important to consistently update your beneficiary.

Supplemental Life Insurance

We offer supplemental life insurance for those who want additional protection. Increase your policy five times your annual base salary, up to \$500,000. You can purchase up to \$20,000 for your spouse and \$2,000 or \$4,000 for your child(ren).

Short-Term & Long-Term Disability

We know that circumstances are different in each situation, and so we have both Short-Term and Long-Term Disability options. These are things we believe you shouldn't have to worry about as you focus on recovery. There are specific guidelines around these programs, which govern how they are used.

Voluntary Benefits

The following voluntary benefits are opportunities for you to receive protection in the areas you deem necessary. Because we make these products available to you, you get the benefit of a group discount.

Critical Illness Insurance

Helps provide financial protection in-case a critical illness strikes you or your family. With this policy you choose how much to purchase and can use the benefit however you fit.

Accident Insurance

Designed to help cover out-of-pocket expenses and the money goes directly to you. The benefit amount is determined by the type of injury, however you can decide how and where to use the designated amount.

Hospital Indemnity Insurance

If you or a family member are admitted into the hospital, Hospital Indemnity Insurance will pay you directly to help with the finances of your stay. You will receive \$1,000 once admitted and an additional \$200 for every day you stay up to a year. You also received a \$50 Health Screening benefit which pays an annual benefit for one covered screening such as blood tests, chest x-rays and COVID-19.

Identity Theft Insurance

This insurance reduces your risk of identity theft and provides resources to help restore your identity if stolen.

Legal Plan


The legal plan provides personal legal services for eligible associates, their spouses and dependent children such as will preparation, the sale of purchase of a home and counsel regarding traffic tickets.

Auto/Homeowners Insurance




Matched Charitable Giving For Time Or Money
